# **Event Summary**

More than 100 delegates from New Zealand and Pacific Nations of Samoa, Tonga, Fiji and the Cook Islands attended the inaugural Pacific People's Housing Forum. First of its kind, this one-day event brought together representatives from local and national Government, private sector and academia to dialogue, collaborate and problem-solve on Pacific People's housing both in the Pacific and in New Zealand.

The theme of the forum "powering collaboration for housing impact" received high-level support with Hon. Jenny Salesa, Minister for Building and Construction. She stated in her closing address the government's commitment to addressing housing affordability concerns in the Pacific community by adopting a rent-to-buy programme and a shared equity initiative.

In addition, Vui Mark Gosche, Deputy Chair of Housing New Zealand agreed to deepen collaborative relationships between Housing New Zealand, community housing providers and Pasifika service organisations.

Panel discussions on disaster response and resilience highlighted the need for an assets-based approach for development, where the skills and strengths within the community are leveraged. In doing so, dependency and reliance on aid are reduced. "We need to work in partnership with affected communities", explained Leveni 'Aho, former Director for the National Disaster Management Office in Tonga.

The housing finance panel discussed the need for more effective financing options for post-disaster housing within the Pacific. Vaine Nooana-Arioka, Managing Director for Bank of the Cook Islands emphasised the importance of collaboration and availing resources ahead of the next big disaster event.

Other highlights included contributions from Pacific young people on housing adequacy. Prior to the forum, organisers hosted an essay competition for young people aged 16-18 based in the Pacific. Entrants answered the question "Habitat for Humanity is working toward a world where everyone has a decent place to live. What are your hopes for housing in your country?" Three finalists representing Samoa, Tonga and Fiji presented excerpts of their essays during the forum. 'Ana Malia Falemaka illustrated the importance of decent housing with her statement "home is the starting place of love, hopes and dreams – especially the dreams of children".



#### **Overview of Discussions**

#### Affordable Housing and Innovations in Housing Finance

Within Pacific communities in New Zealand, homeownership levels have fallen drastically to only 18% compared with over 50% in the 1980s. Additionally, Pacific communities are only 7% of the total population but constitute 36% of state housing tenants.

Expanding the accessibility of affordable housing will require leadership from all major stakeholders. The government can give greater support to pathways to home ownership for people on lower and modest incomes such as rent-to-buy schemes or shared ownership schemes. Vui Mark Gosche pointed out that this could be more cost-effective than the current practice of providing accommodation supplements, which does not address the root cause of housing unaffordability.

Additionally, financial capability programmes as recommended by Vui Mark Gosche will help ensure the success of families when they become homeowners. "It shows that we can do it, but it takes collaboration", he stated.

Within the Pacific, creative collaboration with the public and private sector will help produce more effective financing options for post-disaster housing. This should be bolstered by directing more resource towards disaster risk reduction programmes. In addition to the significant impact of saving human lives, effective planning can reduce the financial impact of natural disasters.<sup>1</sup>

#### **Disaster Resilience**

The collaboration was seen as a vital component of building resilience to disasters in the Pacific. First, by working in partnership with affected communities, long-term sustainability and community empowerment is promoted. Secondly, in relation to disaster-response activities, proper coordination will ensure timely and effective support is given to disaster-affected communities. As such, there is an opportunity for Pacific diaspora communities in New Zealand, Australia and the United States to amplify the impact of their post-disaster support if they are coordinated with government agencies and aid agencies.

#### Quality of housing

Within New Zealand, poor quality rental housing due to the aging housing stock is a significant issue for Pacific families. In addition to addressing this, more culturally appropriate housing designs need to be developed for various kinds of Pacific households.

In the Pacific, there is a range of issues that affect housing quality and consequent disaster resilience. These include lack of skilled carpenters, limited access to high-quality building materials due to cost and remoteness as well as the limited reach of government policies and building codes. An integrated approach is required for addressing these challenges. Some strategies include improving the accessibility of building codes, expanding access to training in disaster-resilient building techniques and research into traditional and emerging building materials and techniques.

#### **Climate Change**

Nobel Prize-winning climate analyst Penehuro Lefale stated that effective strategies to address climate change must start with a clear understanding of the definition of climate change itself. At present, differences exist between the United Nations definition and the scientific definition, giving rise to confusion and inertia in political will. Additionally, consideration should be given to the physical context where normal seasonal weather activity should be differentiated from long-term patterns.

It was also noted that effective housing strategies should not conflate the work areas of disaster risk reduction and climate change. Although related, each is its own speciality. Improving disaster resilience must work in tandem with the political will to reduce carbon emissions, particularly from fossil fuels. Failure to do so will lead to increasing numbers of climate refugees. This has implications for housing in countries like New Zealand as well as in the Pacific.





# Recommendations and Next steps

The following are outcomes of discussions or announcements made at the Forum.

**Climate Change:** A recognition of the need for more published climate change research from the Pacific, in order to ensure adequate representation in global strategies and actions.

**Housing Affordability in New Zealand:** The New Zealand Government is working towards developing a scalable rent-to-buy product as well as shared ownership products for people on low-to-modest incomes.

#### **Collaboration:**

- Housing New Zealand Board to meet with Community Housing Providers and Pacific Specialist Organisations to develop strategies for improving housing for Pacific Families.
- Association of Development Financing Institutions in the Pacific to hold discussions with specialist-shelter organisations to advance the housing finance agenda for the Pacific.
- Collaboration with HNZ standards team and relevant stakeholders on design requirements for Pacific families.

**Youth:** Establishing a Habitat Young Leaders group to advocate for housing in the Pacific

## **Strengthening Pacific Focus:**

- Send a team of representatives from the Pacific to the Asia-Pacific Housing
  Forum in Bangkok in September to raise the visibility of Pacific housing issues in
  the wider region.
- Host future Pacific People's Housing Forums in Auckland. The next one to be a collaboration with the University of Auckland.
